IF NHTSA TRULY STANDS BEHIND THEIR MOTTO, "PEOPLE SAVING PEOPLE" THEN YOU MUST PUT CONSUMER SAFETY FIRST BY RECALLING THESE TIRES ON THESE VEHICLES. BY ALLOWING FORD AND FIRESTONE TO AVOID AN EXPENSIVE RECALL, OUR GOVERNMENT IS STANDING BY AS PEOPLE DIE. ALL THIS IN THE NAME OF MONEY.
