THE DRIVER'S SIDE DOOR CONTINUES TO PUSH THE WINDOW INTO THE RUBBER GROMET AFTER IT HAS ALREADY REACHED THE TOP, CAUSING THE WINDOW MOTOR TO GRIND AND THE WINDOW TO OVEREXTEND INTO THE RUBBER GROMET.
