WINDSHIELD WIPERS WORK SOMETIMES BUT MORE THEN OFTEN DO NOT WORK. I CALLED GMC AS THERE WAS A RECALL BUT THEY TELL ME MY VIN NUMBER WAS NOT PART OF THE RECALL. THE RECALL WAS A MONTH BEFORE I BOUGHT THE TRUCK. WHY DO I HAVE THE SAME PROBLEM BUT I'M NOT PART OF THE RECALL? ON THE BRAKES- IT WAS RECALLED FOR THE ANTILOCK ON A VOLUNTEER BASIS. I TOOK IT IN FOR THE COMPUTER ADJUSTMENT AS PER THE RECALL FIX, THEY SAID IT WAS DONE AND A WEEK LATER, ON THE SAME ROAD IT FIRST HAPPENED TO ME, A LIGHT CHANGED, I HIT THE BRAKES (NOT HARD) AND ANTILOCK KICKED IN AND THE PEDAL WENT TO THE FLOOR AND I ALMOST CRASHED AS MY HEART WENT INTO MY STOMACH. LONG BEFORE THE RECALL, I HAD MY TRUCK INTO GMC MANY TIMES FOR BRAKE PROBLEMS AND EVEN WROTE LETTERS THAT DESCRIBE TH
