VEHICLES TAKEN TO PA INSPECTION STATION FOR YEARLY REQUIRED INSPECTION. TECHNICIAN FOUND CRACKS IN BOTH FRONT DISC BRAKE ROTORS AND SEVER DRAGGING OF THE CALIPERS. VEHICLE WOULD NOT PASS INSPECTION AND REPAIR FACILITY RECOMMENDED REPLACING ROTORS AND CALIPERS. ALL PARTS ARE ORDERED AND EXPECT REPLACEMENT IN SEVERAL DAYS. CONTACTED FORD MOTOR COMPANY TO FIND OUT ABOUT RECALLS; NONE LISTED. ASK ABOUT REPLACEMENT OR REPAIR IN OUT-OF-WARRANTY SITUATION BECAUSE OF SAFETY ITEM; THEY SAID NO BECAUSE IT WAS OUT OF WARRANTY. MY CONCERN IS THAT POSSIBLY MORE THAN JUST MY VEHICLE HAS DEVELOPED THE CRACKS IN THE ROTORS BECAUSE OF A DEFECT IN THE PART. I FEEL THIS IS A SERIOUS SAFETY ISSUE BECAUSE OF THE WEIGHT AND SIZE OF THE UNIT. AS A MOTORHOME
