MY MECHANIC NOTED THAT O2 SENSOR FAILURE IS NOT UNCOMMON ON '97 & '98 GOLFS. IF SO, PLEASE CONSIDER INVESTIGATING FOR A RECALL. CONSUMERS SHOULD NOT HAVE TO PAY FOR A MANUFACTURER'S POOR QUALITY.
