TODAY THE COLUMN LOCK FAILED FOR THE 5TH TIME ON MY 1998 CORVETTE. ONCE THE COLUMN LOCKED ON ME AFTER I HAD BEGUN TO LEAVE A PARKING LOT AND THE CAR SHUT DOWN ON ME. HAD I BEEN AT AN INTERSECTION, I MIGHT HAVE BEEN SERIOUSLY INJURED OR KILLED. FORTUNATELY (OR UNFORTUNATELY AS IT MAY BE) THE OTHER TIMES THE COLUMN LOCK FAILED TO RELEASE WERE AFTER I HAD PARKED THE CAR AND RETURNED. SO FAR, I HAVE ONLY BEEN GREATLY INCONVENIENCED OR HAD MY FRIENDS INCONVENIENCED, BUT I AM AWARE THAT THIS PROBLEM IS NOT UNCOMMON AMONG C5 OWNERS. IT IS TIME FOR A RECALL FOLKS! ENOUGH OF "UNDER CONSIDERATION".*AK
