THE POSTS ON EACH SIDE OF THE WINDSHIELD ARE APPROX. 6" WIDE AND RESTRICT THE DRIVERS VISABILITY SERVERLY. MY SON AND I HAVE SIMILAR TRUCK DODGE TRUCK MODELS AND WE HAVE HAD SEVERAL NEAR ACCIDENTS INVOLVING PEDESTRIANS AND VEHICLES. MY MOST RECENT NEAR COLLISION WAS WITH A RAILROAD LOCAMOTIVE AT AN UNGATED CROSSING. LUCKLY ANOTHER DRIVER ALERTED ME TO THE LOCAMOTIVE AND I SAW IT IN TIME .
