I WOULD APPRECIATE GETTING THIS REPAIRED AS OPPOSED TO "CANNOT DUPLICATE." I DO KNOW THE SUSPENSION HAPPENS FAR MORE OFTEN THAN A VEHICLE THIS YOUNG AGE SHOULD. THANK YOU.
