BOTH HEAD GASKETS FAILED THIS MONTH, AFTER ADDING 50000 MILES, AND FORD WILL NOT DISCUSS REPAIRS. 3.8 L ENGINES IN SOME OTHER MODELS ARE COVERED BY AN EXTENDED WARRANTY BECAUSE FORD HAS RECOGNIZED A DEFECT IN THE GASKETS BUT WILL NOT CONSIDER MINE. THIS IS THE SECOND FAILURE IN ONLY 3 YEARS, 50000 MILES. \*AK
