IF THE LOWER CONTROL ARM KEEPS SHIFTING, I'M SURE THE BOLT THAT KEEPS THE CONTROL ARM IN PLACE WILL EVENTUALLY BE SHEARED OFF.....CAUSING LOSS OF CONTROL.
