THE LEFT LOWER CONTROL ARM BOLT IS MOUNTED IN A SLOTTED HOLE WITH NO LOCKING MECHANISM. THIS ALLOWS THE LEFT FRONT WHEEL TO GO OUT OF ALIGNMENT AND MAKE "CLUNKING" NOISES. I AM PERSONALLY AWARE OF AT LEAST 237 FAILURES OF THIS MODEL THROUGH THE F150ONLINE MESSAGE BOARD. FORD MAINTAINS THAT IT IS NOT A PROBLEM AND REFUSES TO FIX IT. MY DEALER, BELL FORD, WILL NOT FIX THE PROBLEM WITHOUT AUTHORIZATION FROM FORD. THUS, A VEHICLE WITH THE POTENTIAL FOR LOSS OF CONTROL REMAINS ON THE ROAD.*AK
