NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

I HAVE HAD REPEATED PROBLEMS WITH THE ELECTRICAL SYSTEM ON THIS VEHICLE. IT HAS BEEN SERVICED BY TWO DIFFERENT DEALERS A TOTAL OF 4 TIMES FOR THE SAME DEFECTS WHICH STILL REMAIN. THE DRIVERS ELECTRIC SEAT OCCASIONALLY MOVES BOTH FORWARD AND BACK WHILE DRIVING MOVING YOU EITHER AWAY FROM THE BRAKE PEDAL OR INTO THE DASH. THE STEERING WHEEL WHICH IS TIED INTO THE SAME SYSTEM SOMETIMES REFUSES TO MOVE OUT OF ITS RETRACTED POSITION AGAINST THE DASHBOARD. ADDITIONALLY, THE REAR DOORS WON'T OPEN AT ALL UNLESS THE DRIVER FIRST OPENS THEIR OWN DOOR OR HITS A CENTRAL RELEASE BUTTON PRIOR TO EITHER REAR PASSENGER TOUCHING THEIR INTERIOR HANDLES. UP UNTIL NOW THE MANUFACTURER HAS BEEN TRYING TO REPAIR THIS SITUATION BUT HAS NOW CHANGED THEIR POSITIO
