THE FIRST TIME TIRES WERE ROTATED, ONE TIRE COULD ONLY BE "ALMOST" BALANCED; I DROVE THE CAR FROM CHAS., SC TO ATLANTA HAD A FLAT TIRE THAT TURNED OUT TO BE A DEFECTIVE RIM NOT TIRE. RECENTLY HAD TIRES ROTATED AND ALIGNMENT DONE. CAR PULLED TO THE RIGHT; TOOK IT BACK NOW CAR PULLS TO THE LEFT. EVENING OF 6/29 ON I-26 EAST-BOUND EXPERIENCED A COMPLETE LOSS OF STEERING CONTROL. CAR SPUN OUT AND HIT CENTER RETAINING WALL. NO INJURIES OTHER THAN SEAT-BELT BRUISES. WAITING FOR ESTIMATE ON DAMAGE - ENTIRE RIGHT SIDE DAMAGED. *AK
