VEHICLE WAS INVOLVED IN AN ACCIDENT TO RIGHT SIDE IN JANUARY 2000. AIRBAGS DID NOT EMPLOY. ON MAY 12, 2000 WHILE DRIVING ON A ROUTE #32 IN THE TOWN OF WESTMINSTER, MD., THE AIR BAG LIGHT CAME ON AND THE BAGS DEPLOYED FOR NO APPARENT REASON. LAWRENCE SUBARU IN HANOVER PA WAS NOTIFIED AND SUBARU SENT AN EMPLOYEE TO HANOVER TO INSPECT THE CAR. AT NO TIME DID SUBARU STATE THAT THERE HAD BEEN A RECALL ON THIS VEHICLE #98V315000. NO NOTIFICATION OF RECALL WAS EVER RECEIVED PREVIOUS TO DEPLOYMENT. ON THE DAY OF THE INSPECTION, SUBARU DID NOT SAY ANYTHING ABOUT THIS DEFECT. THEY INSPECTED THE VEHICLE AND POINTED TO THE PREVIOUS RIGHT SIDE DAMAGE AND DAMAGE UNDER THE VEHICLE AND SAID THE BAGS DEPLOYED BECAUSE THE CAR HIT SOMETHING. THERE IS NOT NOW
