THE TRANSMISSION IS TOO EASY TO SHIFT FROM 5TH INTO 2ND AND I ALMOST BLEW THE ENGINE. THIS PROBLEM IS KNOWN BY TOYOTA BUT THEY ARE NOT WILLING TO FIX THE PROBLEM. AS FOR THE CRUISE CONTROL, EVERY 2000 CELICA HAS THE SAME PROBLEM. THE CRUISE CONTROL SLOWS DOWN WITHOUT WARNING UP TO 20MPH.
