THERE MUST BE A MANUFACTURING DEFECT WITH MY BREAKING SYSTEM. COLEMAN AUTOPLEX TELLS ME THAT THIS CAR IS NOT DESIGNED TO BE DRIVEN HIGHWAY FOR AN HOUR AND FIFTEEN MINUTES ONE WAY TWICE A DAY BECAUSE THE BRAKES WILL GET HOT AND CAUSE THE ROTORS TO WARP. I DO NOT BELIEVE THIS IS TRUE BECAUSE GMC/ CHEVROLET WOULD NOT PRODUCE SUCH POOR QUALITY/ WORKMANSHIP FOR ITS CUSTOMERS. I HAVE A 1988 DELTA88 OLDSMOBILE WHICH I HAVE PUT 250,000 MILES ON AND I HAVE NEVER HAD SUCH A PROBLEM WITH THE BRAKES. WILL YOU PLEASE HELP ME?
