ELECTRONIC THROTTLE SYSTEM (ETS) DASH LIGHT ILLUMINATED. ENGINE SPEED ELECTRONICALLY AUTOMATICALLY CUT BACK FROM 30 MPH AND HELD TO APPROX 10 MPH. I COULD NOT ACCERLATE. ACCELERATION RESTRAINED LIKE THERE WAS A GOVERNOR ON THE ENGINE. FOLLOWED OWNERS MANUAL INSTRUCTION. 4 TIMES CAR TURNED OFF AND ON AND LIGHT STAYED ON. LET CAR SIT ONE HOUR. THROTTLE SYSTEM RETURNED TO NORMAL AFTER WAITING ONE HOUR BEFORE RESTARTING. PROBLEM NOT REOCCURRED FOR 2 DAYS NOW. CONTACTED DEALER--NO CLUE AS TOO PROBLEM. RELATED TO CURRENT TSB REGARDING THROTTLE SYSTEM. \*AK
