**THIS IS THE THIRD INCIDENT OF THIS TYPE ON THIS CAR. THE STEERING COLUMN LOCKS UP ON THE VEHICLE MAKING THE CAR INOPERABLE. THIS IS A WELL KNOWN DEFECT ON THIS CAR THAT COULD CAUSE A SERIOUS ACCIDENT IF IT WERE TO OCCUR WHILE DRIVING. MY CAR IS CURRENTLY AT THE DEALERSHIP FOR THE SECOND TIME WITHIN 6 WEEKS FOR THE SAME PROBLEM. THE DEALER DOESN'T KNOW WHAT CAUSES THE PROBLEM, AND CONSEQUENTLY HOW TO FIX IT. GM BARLEY ACKNOWLEDGES THE PROBLEM EVEN EXISTS, SAYING THEY HAVE BEEN WORKING ON A FIX FOR THE PROBLEM. THEY DON'T SEEM TO PERCEIVE IT AS A SAFETY ISSUE. I FEEL AS THOUGH THIS COMMON DEFECT NEEDS TO BE THE SUBJECT OF A RECALL BY THE MANUFACTURER SO THAT THE OWNERS OF THESE CARS CAN FEEL SAFE WHILE DRIVING THEM.\*AK**
