ENGINE DEVELOPED A VERY SERIOUS KNOCKING AND BANGING, AND RECENTLY LOSS OF OIL PRESSURE AND LOW OVER 3 QUARTS OF OIL IN ABOUT 800 MILES AFTER OIL CHANGE. THE KNOCKING AND BANGING GOT SO BAD THAT I COULDN'T MAINTAIN HIGHWAY SPEEDS CAUSING A TRAFFIC HAZARD. IF ATTEMPTING TO PULL OUT AND PASS THE KNOCK MAY PREVENT ACCELERATION CAUSING A HEAD ON COLLISION. CONTINUED KNOCK WILL RESULT IN ENGINE FAILURE AND DAMAGE.
