IF CHRYSLER HAS INTENTIONALLY INSTALLED A FAULTY SAFETY DEVICE INTO THEIR VEHICLES, THEY SHOULD BE RESPONSIBLE FOR REPLACING IT, NOT THE CONSUMER. A CRITICAL SAFETY PART SHOULD NOT FAIL SO EARLY IN THE LIFE OF AN AUTOMOBILE.
