NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

MY VEHICLE WAS PURCHASED IN FEB. 1996. WITHIN ONE YEAR IT HAD BEEN RECALLED AND SERVICED FOR SEVERAL REASONS. THE FIRST INCIDENT WAS THE FUEL PUMP MODULE. THE AMOUNT OF GAS ON THE READING REVEALED 1/4 OF THE TANK STILL FULL, HOWEVER THE TANK WAS ACTUALLY EMPTY. ALSO WITHIN THAT YEAR I BEGAN NOTICING WATER IN THE BACK SEAT AND IN THE SPARE WHEEL WELL, DUE TO A LEAK IN THE REAR WINDOW SEAL. SIX MONTHS LATER THE SAME VEHICLE BEGAN LEAKING OIL AND WHEN SERVICED IT WAS FOUND TO BE A HEAD GASKET LEAK. THE GASKET AND IT'S COMPONENTS WERE REPLACED UNDER WARRANTY. IN ADDITION TO OTHER RECALLS THE VEHICLE HAS BEEN SERVICED REGULARLY. HOWEVER, WITHIN THE FOUR YEARS THIS CAR HAS BEEN REVEALING SYMPTOMS THAT ARE UNBELIEVABLE FOR SUCH SHORT AMOUNT OF TIME.
