## NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

RECALL HEADLIGHTS DOES NOT EXAMINE 4-PRONG CONNECTOR TO MULTI-FUNCTION SWITCH (HEADLAMPS). CONNECTOR CASING COMPLETELY BURNED THROUGH; 1/2 INCH OUTER EDGE, 3/16 INCH INNER EDGE, WITH SIGNS OF BURNING AND MELTING MULTI-FUNCTION CASING INNER AND OUTER NEXT TO SWITCH ASSEMBLY IGNITION CAUSING INSUFFICIENT OPERATION OF HEADLIGHTS. FOG LAMPS USED AT ALL TIMES DURING OPERATION OF HEADLAMPS. POSSIBILITY OF FIRE?! HEADLIGHTS FLICKER/SHUTOFF WITH OPERATION OF FOG LAMPS BUT RETURN TO NORMAL ONCE FOG LAMPS SHUTDOWN, EVEN WITH DAMAGE TO CONNECTOR. DEALERSHIP SERVICE ASSUMED MULTI-FUNCTION DEFECTIVE BUT WOULD NOT ACKNOWLEDGE AND/OR EXAMINE THE POSSIBILITY OF ELECTRICAL PROBLEM ASSOCIATED WITH HEADLAMP SWITCH. DEALER DID NOT NOTIFY OWNER OF EI
