THE EXTERIOR PAINT HAS NOT WORN OFF IN A NORMAL FASHION. IT HAS FALLEN OFF IN LARGE (AVERAGE 3-INCH DIAMETER) CHUNKS, LEAVING BEHIND UNSIGHTLY SPOTS OF EXPOSED (AND THEREFORE RUSTED) METAL FRAME. THIS EXTREME AND STRANGE WEATHERING PROCESS WAS NOT CAUSED BY SOME EXTREME CLIMATIC CONDITIONS BUT MAY HAVE HAPPENED BECAUSE OF A POOR PAINT JOB OR LOW QUALITY PAINT. NO SAFETY DEFECT MENTIONED IN SUMMARY. *AK
