IT WAS NECESSARY TO REPLACE THE DRIVER SIDE HEADLAMP ASSEMBLY. AFTER DOING SO I NOTICED A TREMENDOUS DIFFERENCE IN THE NEW HEADLAMP AND THE ORIGINAL. THE ORIGINAL BEAM WAS SO DIFFUSED AND YELLOW COLORED THAT MY NIGHT TIME VISION WAS REDUCED GREATLY. I REPLACED THE PASSENGER HEADLAMP ASSEMBLY ALSO, TO IMPROVE MY NIGHT TIME DRIVING. AFTER THIS OCCURENCE I HAVE NOTICED OTHER VEHICLES WITH THE SAME PROBLEM. THIS IS SOMETHING THAT HAPPENS OVER TIME AND IS A SERIOUS SAFETY ISSUE REGARDING NIGHT TIME VISIBILITY.
