THE DOORS WILL LOCK AUTOMATICALLY WITH THE KEY IN THE IGNITION OR NOT. WE HAD A BABY IN THE CAR AND THE DOORS AUTOMATICALLY LOCKED. THIS HAS BEEN A PROBLEM SINCE 35,000 MILES RECENTLY FORD TOLD US THEIR WAS A RECOMMEND FIX - SERVICE MESSAGE 11243 BECAUSE OF NUMEROUS COMPLAINTS BUT IT IS NOT A RECALL. AS A SAFETY PROFESSIONAL I THINK THIS IS OUTRAGEOUS - POTENTIAL ENTRAPMENT OF SMALL CHILDREN WITHOUT ADEQUATE ESCAPE MECHANISM (NOT BREAKING THE WINDOW) IS A CONCERN.
