NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

WHILE TRAVELLING ON THE I-5 IN FRESNO AT APPROXIMATELY 70 MPH I HEARD A LOUD POP/BURST AND THE VEHICLE REAREND SLID TO THE LEFT INTO THE CONCRETE CENTER DIVIDER I MOMENTARILY LOST CONTROL AND THE ENTIRE LEFT SIDE OF MY TRUCK SCRAPED ON THE CENTER DIVIDER, AFTER GAINING CONTROL I MOVED TO THE RIGHT SHOULDER. I SAW SPARKS COMING FROM THE RIGHT REAR SECTION OF MY CAR WHILE MOVING TO THE SHOULDER. I GOT OUT AND SAW THAT MY RIGHT REAR TIRE HAD "EXPLODED" AND ALL THAT WAS LEFT WAS THE BEADING, MELTED TO THE RIM, AND THE TREAD WRAPPED AROUND MY RIGHT REAR AXEL. I CHANGED THE TIRE AND PROCEEDED HOME. NO ONE WAS INJURED. *AK
