THE TIRE TREAD ON TWO OF MY FOUR TIRES BEGAN TO SEPARATE TO THE POINT THAT THE STEEL CORDS WERE SHOWING THROUGH. SMALL PIECES OF RUBBER WERE MISSING AND OTHER PIECES WERE LOOSE AND READY TO SEPERATE. THE CONDITION WAS NOTICED DURING NORMAL TIRE ROTATION AFTER A TRIP DURING VERY HOT WEATHER. THIS IS THE SECOND SET OF TIRES THAT HAVE FAILED. ANOTHER SET WAS REPLACED FOR THE SAME CONDITION 2 YEARS AGO. BOTH TIMES AFTER THE HOT SUMMER MONTHS. MY FAMILY AND I ARE VERY FORTUNATE THE TREAD DID NOT SEPERATE WHILE WE WERE TOWING THROUGH THE MOUNTAINS AND THE CONDITION NOTED DURING NORMAL TIRE ROTATION. I WOULD ALSO LIKE TO ADD THAT THE TIRES ARE CHECKED FREQUENTLY FOR PROPER AIR INFLATION AND CONDITION. THANK YOU. *AK
