I THOUGHT MY FRONT END WAS SHAKING FOR ABOUT TWO WEEKS. I WAS ON THE HIGHWAY TRAVELLING ABOUT 40MPH BECAUSE I WAS CONCERNED ABOUT THE TIRE. MY CHILDREN AND I HEARD A LOUD BANG AT THE SIDE OF THE CAR.
