THE HOUSING HAS BURNED TO WHERE THEY AREN'T ABLE TO ATTACH NEW COMPONENTS TO IT. THANK YOU FOR LOOKING INTO THIS. IT SEEMS TO ME, THAT IF MITSUBISHI HAS HAD THIS KIND OF PROBLEM IN MANY OTHER MONTEROS, THEN THEY SHOULD BE DOING A RECALL. THANKS AGAIN, LORI LANNIGAN NO SAFETY DEFECT LISTED. *AK
