NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

I HAD THREE FIRESTONE TIRES FAIL ON MY FORD EXPORER BETWEEN 8/98 & 4/99. THE FIRST TWO TIME WERE WHILE TRAVELING AT SPEED ON THE HIGHWAY, FROM WHICH I WAS ABLE TO SAFELY AND WITHOUT INCIDENT PULL OFF THE ROAD. BOTH OF THESE FAILURES WERE CATASTROPHIC WITH THE ENTIRE TIRE FALLING APART. THE THIRD FAILURE WAS SIMPLY THE TIRE GOING FLAT. THIS TIRE HAD VISUAL CRACKS ON THE SIDEWALL JUST BELOW THE TREAD. ALL THREE FAILURES WERE INDICATIVE OF TREAD SEPARATION. THE FIRST TWO WERE PRECEDED BY THE VECHILE RIDING ROUGHLY. SHORTLY AFTER EACH INCIDENT I REPLACED THE BAD TIRE WITH THE FIRESTONE ATX OR ATX II AS THIS WAS THE MANUFACTURE'S (FORD'S) ORIGINAL EQUIPMENT. THE EXACT DATES OF THE INCIDENTS ARE ESTIMATED BASED ON THE TIRE REPLACEMENT RECIEPTS. *AK
