WHILE DRIVING OUR EXPEDITION ON THE FREEWAY AT APPROXIMATELY 55 MILES PER HOUR, OVER SMOOTH DRY ROAD CONDITIONS SUDDENLY THE RIGHT REAR TIRE EXPLODED.
