ON 08/08/00, AS I WAS MAKING A RIGHT TURN, THE STEERING WHEEL "LOCKED" AND I WAS UNABLE TO SUCCESSFULLY COMPLETE THE TURN. I HIT THE BRAKES HARD TO STOP MY CAR FROM HITTING ANOTHER VEHICLE. I HAD TO YANK THE WHEEL HARD TO GET IT TO TURN THE WHEELS. LEFT MY CAR W/ DEALER WHO INFORMED ME THAT THE REASON WHY THE STEERING WHEEL LOCKED WAS BECAUSE I HAD JUST GONE THRU A PUDDLE AND IT WET THE BELT CAUSING IT TO LOSE "TRACTION". IF THIS IS THE CASE, THEN THIS WILL HAPPEN AGAIN AND NOT WHEN I GO THRU A PUDDLE. MAYBE IN THE RAIN. IF I "NEED" IT TO SWERVE AWAY FROM DANGER, I MAY FIND MYSELF A "SITTING DUCK". IS THERE SOME WAY TO COVER THIS AREA SO WATER WILL NOT MAKE THE STEERING BELT LOSE TRACTION?
