THE TREAD OF THE PASSENGER-SIDE FRONT TIRE CAME DETACHED FROM THE TIRE WHILE I WAS DRIVING SOUTH ON I-5 IN SAN DIEGO. MY CAR NEARLY FLIPPED OVER AND SOME DAMAGE WAS DONE TO MY FRONT QUARTER ON THE PASSENGER SIDE. I DID NOT KNOW THERE HAD BEEN NUMEROUS COMPLAINTS ABOUT THESE TIRES DOING THE SAME THING TO OTHER PEOPLE, SO I REPLACED THE TIRES MYSELF AT A COST OF \$546 OUT OF FEAR FOR SAFETY WITH THOSE TIRES. I'M CONCERNED THAT FIRESTONE WILL TRY TO IGNORE PEOPLE WHO HAVE ALREADY PURCHASED NEW TIRES ON THEIR OWN, EVEN THOUGH IT WAS FIRESTONE'S DEFECTIVE TIRES THAT NEEDED TO BE REPLACED.
