TIRE FAILED AS TREAD SEPARATED FROM TIRE BODY. ALTHOUGH TIRE WAS REPLACED VIA PRO-RATA VALUE OF TIRE TREAD USED, WE REPLACED THE FIRESTONE TIRES WITH MICHELIN TIRES ON MARCH 24, 1999. WE DID THIS BECAUSE OF LACK OF TRUST IN THE FIRESTONE TIRES, AND EVEN THOUGH THE FIRESTONE TIRES WOULD HAVE BEEN GOOD FOR ANOTHER 20000 MILES OR SO BASED ON TREAD LEFT.. ^AK
