I WAS TRAVELING ON I-5 IN IRVINE, CALIFORNIA WHEN MY VEHICLE BEGAN TO VIBRATE & THE LEFT REAR TIRE DISINTEGRATED. UPON FURTHER INSPECTION, 1 OF THE REMAINING 3 TIRES WAS DETERMINED TO BE DEFECTIVE. BRIDGESTONE/FIRESTONE SETTLED MY CLAIM FOR THE COST OF BODYWORK AND REPLACED ALL 4 TIRES. I AM CONCERNED THAT THE PROBLEMS REPORTED WITH ATX & ATX II TIRES ARE NOT ISOLATED TO THOSE MODELS. MY EXPERIENCE WAS IDENTICAL TO THOSE RELATED TO ATX & ATXII FAILURES. I STRONGLY SUGGEST THAT THE NHTSA'S INVESTIGATION INTO BRIDGESTONE/FIRESTONE TIRES BE EXTENDED TO INCLUDE THE DEALER HT LT265/75R16 MODEL FOR SAFETY ASSURANCE.
