OUR PROBLEM WAS THE SAME TIRE TREAD SEPARATION ON ESSENTIALLY NEW TIRES WITH THE FOLLOWING TIRE NUMBER: LT225 75R/16M/S. SHOULD RECALL EXTEND TO THESE TIRES AS WELL? WE EXPERIENCED A SEPARATION OF THE LEFT INSIDE REAR FOLLOWED BY THE RIGHT INSIDE REAR ABOUT 150 MILES LATER.
