1989 S-10 BLAZER PURCHASED "NEW" IN FEBRUARY 1989 SUPPLIED WITH FIRESTONE "ATX" TIRES. WITHIN TWO YEARS THE "ORIGINAL TIRES BEGAN TO DEVELOP MAJOR CRACKS IN THE TREAD AREA. THEY WERE REPLACED BY FIRESTONE "AT NO/CHARGE" IN 1992 WITH ANOTHER SET OF "ATX" TIRES. THE REPLACEMENT SET ALSO BEGAN TO DEVELOP MAJOR CRACKING IN THE TREAD AREA WITHIN THE NEXT TWO TO THREE YEARS. IN 1995 THE REPLACEMENT TIRES WERE REPLACED WITH ANOTHER SET OF "ATX" TIRES. HOWEVER, AT THAT TIME THEY (FIRESTONE) PRO-RATED THE TIRE AT ABOUT 50% TREADWEAR AND I HAD TO PAY ABOUT \$160. AGAIN, FOR THE THIRD TIME, THE REPLACEMENT "ATX" TIRES BEGAN TO DEVELOP MAJOR CRACKS IN THE TREAD AREA. LAST MONTH (JULY 2000) I HAD THE TIRES REPLACED AGAIN FOR THE SAME CRACKING PROBLEM. THEY W
