SPEED CONTROL DIS-ENGAGED AT 70 MPH, SPEEDOMETER NEEDLE DROPPED TO APPROX 40 MPH, THEN BOUNCED BACK TO APPROX 55 MPH, SHUT OFF SPEED CONTROL THEN TURNED BACK ON AND WORK FINE. THIS HAPPENED ONE OTHER TIME IN MAY 2000. BOTH TIMES IT WAS AFTER SLOWING DOWN BY TOUCHING BRAKE, USING GAS PEDAL TO CONTROL SPEED, THEN PUSHING THE RESUME BUTTON ON SPEED CONTROL.
