DRIVE TRAIN LOCKED UP CAUSING THE REAR WHEELS TO LOCK UP. THE FRONT WHEELS MAY ALSO HAVE LOCKED UP, BUT UNKNOWN AT THIS TIME. TOTAL LOSS OF CONTROL OF VEHICLE CAUSING THE VEHICLE TO SLIDE SIDWAYS FROM THE LEFT HAND PASSING LANE ACROSS TRAFFIC TO THE RIGHT, HITTING SHOULDER AND ROLLING OVER ONE AND ONE HALF TIMES.
