DUE TO THE RECENT RECALL OF SOME OF FIRESTONE TIRES I WANTED TO ALERT YOU TO THE FACT THAT MY FIRESTONE TIRES WHICH ARE NOT PART OF THE RECALL ALSO EXPERIENCED THE SAME CIRCUMSTANCE. I WAS DRIVING ON AN INTERSTATE AT ABOUT 70 MILES PER HOUR WHEN THE RIGHT REAR TIRES TREAD SEPERATED FROM THE TIRE AND CAUSED THE TIRE TO DEFLATE. I WAS ABLE TO PULL TO THE ROADSIDE BEFORE A BLOWOUT OR FURTHER INCIDENT. THE TIRE HAS ABOUT A 36 INCH LONG AND 3 INCH WIDE SECTION WHERE THE TREAD IS MISSING. THE TIRE OVERALL IS ABOUT 8 INCHES WIDE. I ALSO HAVE A FORD EXPLORER WITH WILDNERNESS AT TIRES THAT WERE NOT MADE AT THE DECATER PLANT AND THUS NOT INVOLVED IN THE RECALL. ALTHOUGH MY FIREHAWK TIRES HAD APPROXIMATELY 60,000 MILES ON THEM AT THE TIME OF THE I
