NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

THE FRONT BRAKE ROTORS HAVE WARPED SIX (6) TIMES ON THIS CAR CAUSING STEERING WHEEL SHAKING AND POSSIBLE LOSS OF CONTROL. INCLUDING THE ORIGINAL ROTORS, THERE HAS BEEN FOUR (4) NEW SETS OF ROTORS ON THIS CAR AND THOSE ROTORS HAVE BEEN RESURFACED THREE (3) TIMES. I HAVE BEEN TO TWO DIFFERENT CHEVROLET DEALERS TO HAVE THIS WORK DONE AND HAVE CONTACTED GENERAL MOTORS DIRECT AND THEY CAN NOT FIGURE OUT WHY THE BRAKES ARE DEFECTIVE. I HAVE HEARD OF MANY CAMARO AND FIREBIRD OWNERS WITH THIS SAME ROTOR WARPING PROBLEM. I FIRST FILED A COMPLAINT WITH NHTSA ON 5/29/99 AND THE ROTORS HAVE BEEN REPLACED TWO MORE TIMES SINCE THAT SUBMITTAL.
