I WAS DRIVING AT APPROX 70 MPH. AMBIENT TEMP APPROX 95 F. TIRES WERE MARGINAL IN TREAD, BUT SHOWED NO SIGN OF DAMAGE. TREAD SEPARATED, BUT TIRE REMAINED INTACT. MAIN INGREDIENTS OF ISSUE. SPEED, HEAT, TIRE AGE. I NOTIFIED BRIDGESTONE/FIRESTONE THAT THEY SHOULD INVESTGATE THIS AS PEOPLE WILL THINK THEIR TIRES ARE OK, BASED ON A LAY-PERSONS VISUAL INSPECTION, BUT THERE MIGHT BE AN UNDERLYING PROBLEM. UNFORTUNATELY THE TIRE COMPANY DISCARDED THE TIRE BEFORE I COULD GET THEM TO LET ME KEEP IT. IT WAS A CLASSIC EXAMPLE OF THE PROBLEM AFFECTING THE WILDERNESS, AT, ETC TIRES, INCLUDING THE FACT THAT IT STAYED INFLATED. I SUSPECT THE PROBLEM IS WIDESPREAD, BUT HAS NOT YET REACHED THE PROPORTION OF THE CURRENT TIRE PROBLEM, OR IT HAS NOT CAUSED CATASTROPHIC RESULTS DUE
