HEADLIGHTS TOO DIM TO SAFELY DRIVE AT NIGHT DUE TO THE FACT THAT THE PLASTIC LIGHT ASSEMBLY IS PERMINATLY FOGGED. 6 YEARS OF HEAT AND MOISTURE HAVE FOGGED THE LENSE. I HAVE BEEN NOTICING THIS EFFECT ON MANY CARS HERE IN FLORIDA WITH THESE PLASTIC HEADLIGHT ASSEMBLIES. REPLACEMENT OF THE TWO LIGHT ASSEMBLES W/LABOR IS \$250. IT WOULD WOULD SEEM TO ME THAT THIS IS A DEFECT IN THE PLASTIC MATERIAL. THESE PLASTIC LENSES SHOULD HAVE BEEN DESIGNED TO OUT LAST THE LIFE OF THE VEHICAL.
