I WAS IN 5:30PM TRAFFIC AND FELT THAT THE CAR WAS NOT RIDING CORRECTLY I DECIDED TO EXIT THE FREEWAY AND WHEN I DID I LOST HALF OF THE TREAD. I STILL HAVE THE TIRE IN MY CAR. I DROVE IMMEDIATELY TO A LOCAL FIRESTONE DEALER AND THE BEST THEY WOULD DO IS PRO-RATE MY ANOTHER BRIDGESTONE DUELER TIRE. I'M STUCK BECAUSE THESE TIRES ARE NOT IN THE RECALL AND SHOULD BE!! NOW I HAVE TO PAY FOR A NEW SET OF TIRES. THIS PROBLEM IS MORE WIDESPREAD THAN BRIDGESTONE LEADS THE PUBLIC TO THINK! PLEASE HELP!!
