IGNITION REPLACED AT 21274 MILES - PROBLEM (WHEN CAR STARTED ELECTRICAL COMPONENTS OF RADIO, WIPERS, A/C DID NOT WORK) THIS STARTED INTERMITTENTLY SHORTLY AFTER PURCHASE, VERY FREQUENT OCCURENCE WHEN CHANGED.
