I RECENTLY RECEIVED AN AUG 17 LETTER FROM FORD MOTOR CO. RE. THE TIRE RECALL. THOUGH I DO NOT HAVE THE RECALLED TIRES I CONTACTED A LOCAL GOODYEAR DEALER AND HAD THEM INSPECT THE TIRES. 3 TIRES ARE SHOWING CRACKING AND BUBBLING AT THE TREAD JUNCTION WITH THE TIRE SHOULDER. IN ADDITION, ONE TIRE HAS UNDERLYING CORD MATERIAL ERUPTING FROM THE BUBBLE. I HAVE CONTACTED FIRESTONE FOR A PLANNED INSPECTION. SEEMS THERE MAY BE A PROBLEM WITH OTHER FIRESTONE TIRES AND I THOUGHT YOU SHOULD KNOW.
