TIRE TREAD CAME COMPLETELY OFF TIRE. I WAS ABLE TO SAFELY STOP VEHICLE. FIRESTONE DEALER IN AURORA COLORADO, STORE # 028924 TOLD ME THAT ALL FOUR TIRES WERE MANUFACTURED AT THE DECATOR PLANT. THEY TREATED THIS LIKE A RECALL AND REPLACED ALL FOUR TIRES AT NO COST WITH GENERAL TIRES. THE FIRST TIRE TO DO EXACTLY THE SAME THING UNDER IDENTICAL CIRCUMSTANCES LOST ITS TREAD ABOUT 6 MONTHS AGO, PRIOR TO PROBLEM IDENTIFICATION AT DECATOR PLANT. SECOND TIRE CAME APART IN WYOMING. I MADE THIS REPORT THINKING THAT THE PROBLEMS AT DECATOR MIGHT EXTEND BEYOND THE TIRES CURRENTLY IDENTIFIED, AS THE AFFINITY TIRES ARE NOT ON THE RECALL LIST. THANKS. DAVE ASHTON
