TIRE TREAD SEPARATED. TIRES WERE PROPERLY INFLATED AND WHERE DRIVEN AT NORMAL HIGHWAY SPEEDS. I TOOK VEHICLE TO DEALER AND BECUASE THE TIRES WERE ONLY TWO YEARS OLD WITH A LITTLE LESS THAN 30,000 MILES ON THEM THEY REPLACED IT. THEY ALSO FOUND ANOTHER BAD TIRE WHICH WAS REPLACED UNDER WARRANTY. MY CONCERN IS THAT THESE TIRES DID THE SAME THING THAT THE FIRESTONE RECALLED TIRES WERE DOING. ALTHOUGH THEY WERE NOT THE RIGHT SIZE NOR WERE THEY MADE AT THE SAME PLANT AS THE RECALLED TIRES, I BELIEVE THAT THESE TIRES ARE ALSO DEFECT AND SHOULD BE INVESTIGATED AS WELL SO AS TO AVOID OTHER POSSIBLE ACCIDENTS OR DEATHS. IT IS A HORRIBLE COINCIDENCE THAT THESE TIRES ARE MADE BY FIRESTONE AND HAD TREAD SEPARATIONS AS WELL AS THE RECALLED TIRES. M
