NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

BOTH FRONT HEADLIGHTS HAVE BECOME SCRATCHED/CLOUDY. LIGHT OUTPUT IS REDUCED. I BELIEVE THAT THESE HEADLIGHT LENSES ARE EASILY SCRATCHED WHEN CLEANING DEBRIS AND DIRT. THIS HAS NOT HAPPENED ON CARS THAT I HAVE OWNED THAT WERE EQUIPPED WITH GLASS HEADLIGHT LENSES. IN ADDITION, I BELIEVE THAT LIGHT OUTPUT ON LOW-BEAM IS INSUFFICIENT EVEN WHEN THE VEHICLE WAS NEW. OTHER GRAND PRIXS I HAVE CHECKED HAVE THE SAME PROBLEM WITH THEIR HEADLIGHTS. THIRDLY, THE HEADLIGHT ASSEMBLIES ARE LOOSLY FITTED TO THE VEHICLE, CAUSING THE HEADLIGHT PATTERN TO SHIMMER WHEN DRIVEN OVER ROUGH ROADS.
