I PAID TO FIX THE PROBLEM OF THE SMELL OF GASOLINE IN APRIL OF 1995 BUT CAR STILL SMELLED LIKE GAS INTERMITTENTLY AND I WAS NEVER TOLD BY ANYONE THAT MY CAR COULD CATCH ON FIRE! THANKFULLY, THE PROBLEM IS FIXED WITH A NEW INJECTOR AND HOSE HARNESS SYSTEM, AND MY FAMILY AND MY HOME ARE NO LONGER IN DANGER OF FIRE BUT BUT I FEEL THAT NISSAN SHOULD PAY FOR PREVIOUS REPAIRS THAT DID NOT FIX THE PROBLEM.
